You agree that you will not overuse our resources, to not chargeback or request refunds. You agree to not invite alts on The "Services" Discord Server or use the "Subscriptions(s)" or "Service" to hack, ddos, or be used to do anything illegal.

You agree to respect the "Services" rules and users

Chargebacks

On the instance a chargeback occurs, you will be denied a refund and your "Service(s)" and/or "Subscription(s)" will be terminated.

Legality

You ("User", "Customer") agree that you will not use our services for anything illegal.

You ("User", "Customer") agree that you will use our services for what it is made for.

You ("User", "Customer") agree that you will not try to abuse / break / bypass our systems.

You ("User", "Customer") agree that you will not run multiple instances on a single server.

REFUNDS

Monthly Plans - Refunds

On the instance if a user (“You” , “Customer”) requests a refund, your refund will be given only if it is requested within the 4 days of “Service(s)” and/or “Subscription(s)” purchase.

On the instance if a user (“You” , “Customer”) requests a refund, and the user (“You” , “Customer”) has Extra Months (Quarterly, Semi-Annually, Annually) remaining / prepaid, the **User’s Refund Amount** will be calculated and refunded to the User **AS STORE CREDIT**.

Lifetime Plans - Refunds

On the instance that a user (“You” , “Customer”) requests a refund, your refund will be given only if it is requested within the 4 days of “Service(s)” and/or “Subscription(s)” purchase.

On the instance that a user (“You” , “Customer”) requests a refund, 4 Days after the Invoice has been generated, and the “Service(s)” and/or “Subscription(s)” are working as intended, the requested refund will not be given. Lifetime Plans are considered as **“ONE TIME PAYMENTS”** and You (“Customer”) are not able to use the service and suddenly request a refund.

Contract Plans - Refunds

On the instance if a user (“You” , “Customer”) requests a refund, your refund will be given only if it is requested within the 4 days of “Service(s)” and/or “Subscription(s)” purchase.

On the instance if a user (“You” , “Customer”) requests a refund, 4 Days after the Invoice has been generated, and the “Service(s)” and/or “Subscription(s)” are working as intended, the requested refund will not be given.
